He also represented DOJ on Capitol Hill, engaging often with elected officials and their staff on proposed legislation and congressional oversight. Previously, as the Staff Director and Counsel for the Subcommittee on Intelligence & Counterterrorism — the top counterterrorism advisor to Chairman Bennie G. Thompson (D-MS) on the U.S. House Committee on Homeland Security — Prasanna led investigations, hearings, and the successful passage of several House bills, often working closely with the minority staff and external stakeholders to win bipartisan support. Prasanna also worked for two senior senators, as a Legislative Aide to Senator Richard Blumenthal (D-CT) and General Counsel to former Senator Bill Nelson (D-FL), providing them with strategic guidance on a range of sensitive and complex issues related to the Senate Judiciary Committee and other Senate committees.
