UNITED STATES' UNOPPOSED MOTION TO DISMISS

The United States files this Unopposed Motion to Dismiss the indictment returned in this case against Ara Aprahamian, pursuant to Federal Rules of Criminal Procedure, Rule 48(a).

On February 20, 2020, a grand jury in the Eastern District of Pennsylvania returned an indictment charging Ara Aprahamian with two counts of conspiracy to restrain trade in violation of 15 U.S.C. § 1 and one count of making a false statement in violation of 18 U.S.C. § 1001. ECF No. 1.

The United States requests that this court dismiss the pending criminal charges in the above-captioned case. Dismissal of this case is not contrary to manifest public interest, and it will allow the conservation of this Court's time and resources. *See United States v. Salinas*, 693 F.2d 348, 352 (5th Cir. 1982) ("[T]he motion to dismiss the indictment should be granted unless the trial court has an affirmative reason to believe that the dismissal motion was motivated by considerations contrary to the public interest.") (internal quotation marks and citation omitted). Counsel for the United States has conferred with counsel for Defendant, who do not oppose this motion, and confirmed that Defendant and Defendant's counsel will comply with the

requirements of the Protective Order, including Paragraph 11, upon entry of this Court's order of dismissal. ECF No. 35.
